(the "Issuer") announces that on 9 February 2011 the Issuer, acting as the syndicate leader, received a mutually signed copy of a subsequent partial agreement within the Framework Agreement with Operator Gazociągów Przesyłowych GAZ-SYSTEM S.A. with its registered office in Warsaw ("GAZ-SYSTEM") for deliveries of externally and internally coated steel pipes for pipelines for combustible fluids. The Issuer announced the fact of concluding the above mentioned Frame Agreement with GAZ-SYSTEM in Current Report No. 68/2010 dated 20 August 2010.
