With reference to Current Report No. 6/2011 dated 26 January 2011 on signing a framework agreement between "FERRUM" S.A. (the "Issuer") and Operator Gazociągów Przesyłowych GAZ – SYSTEM S.A. (the "Buyer") regarding delivery of coated steel pipes (the "Framework Agreement"), the Issuer announces that on 2 August 2011, acting as a syndicate leader, it signed a partial agreement with the Buyer regarding deliveries of coated steel pipes for investment tasks implemented by the Buyer (the "Partial Agreement").

The net value of the Partial Agreement confirmed by the Issuer is PLN 47.7 million. The implementation date of the Partial Agreement is the period from 19 December 2011 till 20 February 2012.

Detailed terms and conditions of the Partial Agreement, including regulations on contractual penalties, were stipulated in the Framework Agreement and were subject to announcement in Current Report No. 6/2011.

The criterion for recognising the value of the Partial Agreement to be significant is 10 % of the equity of "FERRUM" S.A.

Moreover, the Issuer announces that this is the second Partial Agreement entered into in the course of implementation of the aforementioned Framework Agreement. The total net value of the partial agreements confirmed by the Issuer is PLN 108.7 million. Information on the first Partial Agreement was made available to the public in Current Report No. 43/2011 dated 25 July 2011.
