Acting pursuant to Clause 5 par. 1 pt. 6 of the Regulation of the Minister of Finance dated 19 February 2009 on current and periodic information published by issuers of securities [...], the Management Board of "FERRUM" S.A. (the "Issuer", the "Company") hereby announces that on 12 September 2011 the Company purchased 4 197 own shares for the purpose of their redemption or resale.

The buy-back of own shares commenced on the basis of the Resolution of the Issuer's Management Board dated 6 September 2011 on the buy-back of own shares, the "FERRUM" S.A. *Own Share Buy-back Programme* being its integral part, pertaining to purchase not more than 20 % of the Company's own shares for the purpose of their redemption or resale (the "Programme") Current Report No. 49/2011 dated 6 September 2011), which was adopted in order to implement the Resolution No.2/2010 of the Extraordinary General Meeting of Shareholders of "FERRUM" S.A. dated 25 November 2010 (the "Resolution") (Current Report No. 90/2010 dated 25 November 2010).

The buy-back of own shares is carried out through a Brokerage House which purchases the shares on account and in behalf of the Issuer. The aforementioned transaction will be cleared on 15 September 2011.

Underneath the Issuer presents detailed information on the buy-back dated 12 September 2011:

- Number of purchased shares: 4 197
- Average unit purchase price: PLN 7.50
- Number of votes at General Meeting of Shareholders equivalent to the purchased shares: 4 197
- Share of the purchased shares in the Issuer's share capital and in the total number of votes in the Company: 0.0171 %
- Nominal value of each share is PLN 3.09, total nominal value of the purchased shares is PLN 12 968.73.

Total number of own shares purchased within the buy-back on the day of publication of this report is 10 611, which is equivalent to 10 611 votes and 0.0432 % of share capital and the total number of votes.
